



2007 Salon Rebate Program

Receive up to \$5.00 a Bottle Rebate on Supre® Tanning Lotions

Supre® will rebate salons \$5.00 in Supre® product credit for every full size tanning product retailing \$50.00 and above, \$4.00 for every full size tanning product retailing between \$40.00 and \$49.99, \$3.00 for every full size tanning product retailing between \$30.00 and \$39.99 and \$2.00 for every full size tanning product retailing between \$20.00 and \$29.99. All credits must be turned in at one time at the end of the program term, and all products redeemed must be shipped on one order. Supre® reserves the right to substitute like value products for any out-of-stock products on the rebate order form. In order to receive these product credits, mail copies of invoices on which these products were purchased, along with the Supre® Salon Order form.

The rebate program begins January 1, 2007 and ends May 1, 2007. Complete the Supre® 2007 Salon Order forms by indicating the products purchased and multiply times the applicable dollar amount, resulting in your pending product rebate. Then indicate your chosen products on the rebate order form. Be sure your chosen products' salon cost equals your rebate product credit. Please allow 45 days for your product credit to be processed.

Rebate Guidelines:

- Three hundred dollar minimum rebate amount to qualify.
- Products qualifying for rebates must be purchased through an authorized Supre® distributor.
- Salon rebate form must accompany invoices or computerized report from the distributor where products were purchased.
- If a distributor's computerized report is used, the report must contain the following information: Customer name, date, invoice number, product name, size, quantity and unit price. No credits will be issued unless accompanied by ALL required information.
- Rebate credits apply only to full size bottles/tubes of Supre® tanning products, as listed on the rebate order form.
- Back-ordered product does not qualify for rebate credit until it has been shipped and invoiced to a salon.
- No invoices dated after May 1, 2007 will qualify toward rebate credit.
- Supre® must receive rebate submission, salon invoices and signed rebate order form no later than September 30th, 2007. Paperwork received after this date will not qualify for the program.
- Salon and distributor participation are voluntary. Rebates may only be redeemed by current salon owners and are not transferable.
- Rebate products must be redeemed in one shipment. No partial redemptions will be processed and Supre® reserves the right to substitute equal products if a particular item is out of stock.
- Must have valid street address to ship to; no orders will be shipped to P.O. Boxes.
